#### COMMUNICATIONS/REPORTS

#### 1. Griffith Police Department

Chief Mance read the monthly report for July 2024. Chief Mance advised the Board that our Animal Control facility is full beyond capacity. This seems to be true for all the animal control facilities in our area.

### 2. Griffith Fire Department

Fire Chief Schoon read the monthly report for July 2024. Chief Schoon stated they are currently working to get their Survive Alive House ready for the upcoming Safety Day on September 21 and for the Department's Open House scheduled for October 6, 2024. Chief Schoon advised they have signed an agreement with the Highland Fire Department for automatic aid for structure fires, which basically has both departments being paged out together in the event of a structure fire in either community.

# 3. Griffith F.O.P. Lodge #161

There was no representative present tonight from Griffith F.O.P. Lodge #161.

#### VEST

Corporal P. Ghrist read the monthly VEST report for August 2024. Total hours worked by VEST Members for August 2024 were 1,239.25 hours. The top Volunteer for August is Tom Gindl with 315 hours. Honorable Mentions go out to: Mike Andree (286 hours), Ruth Gindl (123.5 hours), Fermin Lopez (114 hours), Robert Bubala (119.75 hours), Mathew Plopper (52.5 hours), Lamar Blanks (70 hours), and Tracy Labuda (55.25 hours). Total hours for 2024 are 6,865.25. There are currently 13 members in VEST, and they have 5 applications for membership. The VEST units worked numerous hours this month at Special Events such as: Central Markets, NWI Symphony Concert, BBQ & Blues Fest, Western Days, and Rock 'N Rail Music and Street Festival.

PSB Member Purgert made a motion to approve the swearing-in of Probationary Firefighter Jennifer Covington (Station 31) to full-time status.

PSB Member Katona seconded the motion

The motion carried 4 - 0.

Deputy Chief Andree advised the following: Jennifer Covington is a Griffith High School graduate. She enjoys spending time with her two beloved fur babies and loves hanging out with her friends and family, especially her nephew Jackson. She loves going to the beach and engaging in outdoor activities.

Jennifer joined our department in September 2023. She was one of three to complete our second ERS Class. She graduated from the District 1 Fire Academy this past June and is currently enrolled in our driver operator course. Jen has proven herself to be an asset to the department and continues to help with numerous events and fundraisers.

PSB Member Katona swore-in Firefighter Jennifer Covington. Chief Schoon presented Firefighter Covington with her Certificate of Promotion recognizing her as a full and active member of the Griffith Fire Department. Deputy Chief Andree presented Firefighter Covington with her shield.

# QUESTIONS/COMMENTS FROM THE FLOOR

Richard Powell, of 1206 E. Lake Street, Griffith, Indiana, stated he had a concern regarding the intersection of E. Lake Street and N. Colfax Street. Mr. Powell stated the southwest corner lot is full of branches and bushes. When a vehicle tries to turn to go North on Colfax Street, they must pull out onto Colfax Street to see. Town Councilman Ryfa stated Chief Mance would handle this matter with Code Enforcement as it is a serious issue, and it is critical that it be addressed. Chief Mance stated he would look into the matter.
