#### 1. Griffith Police Department

Chief Mance announced the Griffith police officers are doing their Annual Fund Raiser (No Shave November), which will raise funds for the Northwest Indiana Cancer Kids Foundation, which helps families with children battling childhood cancer. Officers just held a Pop-Up Coffee Shop which raised

several hundred dollars, and they will be Bussing for Beards on November 19, 2024, at Bridges' Scoreboard Restaurant and Sports Bar, to raise additional monies for NW Indiana Cancer Kids.

Assistant Chief M. Andree advised Ronnie Mitchell started with Griffith Fire in November 2023. He was the last of the 17 hired that year. Ronnie was a transfer from Lake Ridge Fire Department where he served for seven (7) prior years. He is a 2013 graduate from the District 1 Fire Academy. Ronnie has been serving our community well throughout the last year, and we are proud to have him as part of our team.

PSB Member Goral swore in Probationary Firefighter Ronnie Mitchell to full status. Chief Schoon presented Firefighter Mitchell with a Certificate of Promotion. Assistant Chief Andree presented Firefighter Mitchell with his badge.

6. The EMS Board will be making a presentation to the Superior Ambulance crews that responded on June 29, 2024 to the 900 block of Arbogast reference a fireworks incident

Mr. Robert Bubala thanked the Public Safety Board for allowing them to be here tonight. Mr. Bubala and Ms. Dorothy Soverly stood, and Mr. Bubala stated they were here to make a presentation to two (2) Superior Ambulance crew members; namely, Paramedic Robert Madon, and EMT Jody Jiminez. Mr. Bubala then advised the following:

"On June 29th, 2024, at approximately 9:30 P.M., first responders responded to a disturbance in the 900 block of N. Arbogast. Griffith Police arrived and immediately learned it was a horrible firework accident. A large mortar had exploded sending chunks of concrete hurling hundreds of feet into a large crowd, several houses.

and numerous vehicles. The scene was quickly recognized as a mass casualty situation having multiple injuries of differing magnitudes.

Superior Ambulance 3161 responded to the incident, which was staffed by Robert Madon, Paramedic and Jody Jiminez, EMT. Upon arrival, the scene was noted to be chaotic with over 50 people present. The crew was directed to a child that was noted to be critically injured during the explosion. The ambulance crew wasted no time in removing the patient from the chaotic scene with the assistance of Griffith Police Officer T. Watkins. The crew performed lifesaving interventions and rapidly transported the child to the closest facility where a Trauma Team was waiting.

The crew's quick action and critical thinking are a contributing factor to not only the patient's survival, but also to the child making a recovery.

The Town of Griffith Emergency Medical Services Board appreciates the work of Paramedic Robert Madon and EMT Jody Jiminez not only this evening, but to the work they perform daily for the citizens of Griffith."

Robert Bubala and Dorothy Soverly presented Paramedic Robert Madon and EMT Jody Jiminez with Certificates of Accommodation.
