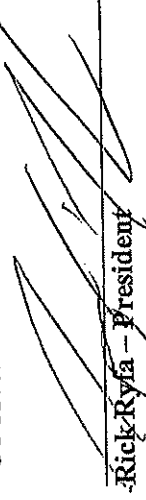

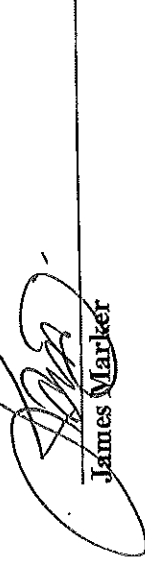

There being no further business to come before this Council, the meeting adjourned to 7:09 p.m.

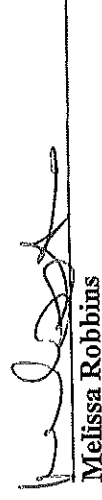
